BE IT ENACTED BY THE OUORUM COURT OF COLUMBIA COUNTY, ARKANSAS

AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE AMENDING AND SUPPLEMENTING THE ANNUAL OPERATING BUDGET FOR THE ASSESSOR'S AMENDMENT 79 FUND OF COLUMBIA COUNTY FOR THE YEAR 2019. AN APPROPRIATION ORDINANCE INCREASING BALANCE BROUGHT FORWARD AND SUPPLEMENTING THE ASSESSOR'S AMENDMENT 79 FUND BUDGET.

WHEREAS, on October 31, 2018 Columbia County Treasurer, Selena Blair, prepared the anticipated revenue for the Assessor's Amendment 79 Fund where she brought forward \$4,250.00; and

WHEREAS, Columbia County Assessor, Sandra Cawyer is in need of purchasing computers for her office; and

WHEREAS, we are hereby increasing the balance brought forward by \$5,600.00 of which 90% or \$5,040.00 is available for appropriation.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF COLUMBIA, STATE OF ARKANSAS:

- **ARTICLE 1** The Quorum Court has found and determined the Columbia County Assessor's Amendment 79 Fund Budget, for Calendar Year 2019, as appropriated by Appropriation 2018.17, is hereby amended as set forth.
- **ARTICLE 2** That the Quorum Court of Columbia County did on June 3, 2019 adopt an amended budget supplementing the Assessor's Amendment 79 Fund Budget, as documented below, for the purchase of computers.

The Honorable Larry Atkinson called the regular meeting of the Columbia County Quorum Court to order. Mr. Williams gave the invocation. County Clerk Tammy Wiltz called roll; 11 members present.

Motion was made by Mr. Lee and 2nd by Mr. Story to suspend the rules and accept the April 2019 minutes as mailed. Ms. Pate questioned the April 9 Special Meeting minutes regarding the recommendation for the Sheriff's Department to reimburse the monies paid to settle Rasberry et al. Other Quorum Court members agreed that the minutes were correct as filed, and no changes were to be made
