#### APPROPRIATION ORDINANCE 2020.

BE IT ENACTED BY THE QUORUM COURT OF COLUMBIA COUNTY, ARKANSAS

AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE SUPPLEMENTING AND AMENDING THE ANNUAL OPERATING BUDGET FOR THE GENERAL, ROAD AND SOLID WASTE FUNDS OF COLUMBIA COUNTY FOR THE YEAR 2019. AN APPROPRIATION ORDINANCE TRANSFERRING WITHIN VARIOUS COUNTY BUDGETS FOR YEAR END CLEAN UP AND SUPPLEMENTING THE SOLID WASTE FUND BUDGET.

WHEREAS, the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) was signed into law on April 7, 1986. Federal law requires employers of 20 or more employees to offer employees who have experienced a qualifying event the right to continue group health coverage for a specified period at applicable group rates plus administrative fees when this coverage would otherwise end.

WHEREAS, we have a solid waste department employee which terminated employment in November and has elected to participate in the COBRA plan; and

WHEREAS, we are hereby increasing anticipated revenue in the amount of \$506.66 to the Solid Waste Fund Budget and the COBRA participants will make monthly payments to the administrator and they will send payments to the county. The county will be responsible for paying the vendor.

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF COLUMBIA COUNTY, ARKANSAS:

**ARTICLE 1** The Quorum Court has found and determined that some of the budgets, for Calendar Year 2019, as appropriated by Appropriation 2018.17, are hereby amended as set forth; and

#### APPROPRIATION ORDINANCE 2020.

BE IT ENACTED BY THE QUORUM COURT OF COLUMBIA COUNTY, ARKANSAS:

AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE ADJUSTING THE BALANCE BROUGHT FORWARD FOR THE ANNUAL OPERATING BUDGET FOR THE RURAL COMMUNITY GRANTS FUND FOR COLUMBIA COUNTY FOR THE YEAR 2020. AN APPROPRIATION FOR COLUMBIA COUNTY COMMUNITY ASSISTANCE GRANT PROGRAM.

WHEREAS, the Legislature passed Act 302 during the 1991 session which established the Arkansas Rural Development Commission and the Office of Rural Advocacy which provides for the Arkansas Rural Community Grant Programs and creates the Rural Grant Fund on the books of the County Treasurer; and

WHEREAS, Columbia County applied for and was awarded a grant through the Arkansas Department of Rural Services, Arkansas Community Assistance Grant; and

WHEREAS, the County was awarded \$50,000.00 which has been received and is in the Treasury;

WHEREAS, the County was also awarded \$32,570.00 from the Arkansas Development and Enhancement Fund to complete the Sheriff's grant. This check is also in the Treasury.

WHEREAS, no budget was prepared for the Rural Community Grant Fund in the 2020 Budget, therefore we are hereby creating and appropriating \$82,570.00 as documented below.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF COLUMBIA, STATE OF ARKANSAS:

- **ARTICLE 1** The Quorum Court has found and determined the Columbia County Rural Community Grant Fund Budget, for the Calendar Year 2020, is hereby created as set forth.
- **ARTICLE 2** That the Quorum Court of Columbia County did on January 6, 2020, adopt the creation of the Rural Community Grant Fund Budget, as documented below, in the sum of \$82,570.00.

The Honorable Larry Atkinson called the regular meeting of the Columbia County Quorum Court to order. Mr. Lee gave the invocation. County Clerk Tammy Wiltz called roll; all members were present.

Motion was made by Mr. Lee and 2<sup>nd</sup> by Mr. Story to suspend the rules and accept the November 2019 minutes as mailed. All were in favor.

#### **COMMITTEE REPORTS**

**BUILDING** – Ms. Blair reported that the Columbia County Election Commission had concerns about the ADA compliance at the West Annex, and that Judge Atkinson was already making necessary improvements. A new contract with the existing company that maintains the jail roof will be renewed for 2020 if the county invests \$9,890 for improvements.

FINANCE - Ms. Pate referenced revenue report from Treasurer's office.

**JAIL** – Mr. Lee reported the freezer had been repaired. Sheriff Loe stated that the \$50,000 grant that they had lost had been reinstated, as well as an additional \$32,750 from the Governor's office for the Crimestar project.
