AN APPROPRIATION ORDINANCE TO BE ENTITLED: AN APPROPRIATION ORDINANCE SUPPLEMENTING AND AMENDING THE ANNUAL OPERATING BUDGET FOR THE GENERAL, ROAD AND JAIL FUNDS OF COLUMBIA COUNTY FOR THE YEAR 2019. AN APPROPRIATION ORDINANCE TRANSFERRING WITHIN VARIOUS COUNTY BUDGETS FOR YEAR END CLEAN UP.

EMERGENCY ORDINANCE NO. 2020.

BE IT ENACTED BY THE QUORUM COURT, COUNTY OF COLUMBIA, STATE OF ARKANSAS: AN ORDINANCE TO BE ENTITLED: AN ORDINANCE ALLOWING COLUMBIA COUNTY TO ADD AN ADDITIONAL VOTE CENTER FOR 2020 COUNTYWIDE GENERAL ELECTIONS AND TO DECLARE AN EMERGENCY:

NOW, THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF THE COUNTY OF COLUMBIA, STATE OF ARKANSAS:

SECTION 1. SOURCE AND AUTHORIZATION

Pursuant to Section 7-5-101(e)(1)(B) of the Election Laws of Arkansas, "...the County may adopt an ordinance to establish vote centers for elections." and is hereby so authorized to add a 7th vote center for the countywide elections.

SECTION 2. SEVERABILITY

If any provision or section of this Ordinance is held invalid by a Court of competent jurisdiction, such invalidity shall not affect other provisions and sections of this Ordinance, and to such end the provisions and sections of this Ordinance are declared severable.

SECTION 3. EMERGENCY CLAUSE

An emergency is hereby declared to exist, and this Ordinance being necessary for the preservation of the public peace, health and safety shall be in full force and effect from and after its passage and approval.

EMERGENCY ORDINANCE 2020.

BE IT ENACTED BY THE QUORUM COURT OF COLUMBIA COUNTY, ARKANSAS:

AN ORDINANCE TO BE ENTITLED: AN ORDINANCE AUTHORIZING THE PURCHASE OF A NEW COMPUTER SOFTWARE SYSTEM AND DATA TRANSFER FOR THE SHERIFF'S OFFICE AND JAIL WITHOUT TAKING BIDS.

WHEREAS, Columbia County applied for and was awarded a grant through the Arkansas Community Assistance Grant Program for the purchase of CrimeStar software system and the transfer of data from the old system to the new system; and

WHEREAS, the grant award wasn't enough for the complete project so the balance of the project is being funded through the Rainy Day Fund authorized by Governor Asa Hutchinson; and

WHEREAS, CrimeStar is a single source provider of this software and is exempt from the bidding procedure, however the data transfer portion is not exempt from the bidding procedures; and

WHEREAS, the need for Whitebox Technologies to do the data transfer at the time the software system is being installed and to have a smooth transition from the old software system to the new software system causes an emergency to exist and the complete project will be done without the procedure of bidding.

NOW, THEREFORE, BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF COLUMBIA, STATE OF ARKANSAS:

ARTICLE 1: This ordinance authorizes the completion of the purchase of the software system and data transfer without the bidding procedure, as stated above.

ARTICLE 2: <u>EMERGENCY CLAUSE</u>. An emergency is hereby declared to exist and this Ordinance being necessary for the preservation of the health, safety, and welfare of the citizens of Columbia County, Arkansas shall become effective immediately upon its passage by the Quorum Court and approval by the County Judge.
